Baragadhi Rural Municipality has received special grants from provincial government towards the cost of **Material Management for Science Laboratory** and intends to apply part of the funds to cover eligible payments under the Contract **BGRM/BARA/G/NCB/2077-78/07: Supply and Delivery of Science Lab Materials for Community Schools**. Bidding is open to all Nepalese Bidders.
2. The Baragadhi Rural Municipality, Office of Rural Municipal Executive, Khopawa, Bara invites **Sealed Bids** from eligible bidders for the **"Supply and Delivery of Science Lab Materials for Community Schools"** under National Competitive Bidding (NCB) procedures specified in Public Procurement Act and Regulations. Bidding is open to all eligible and qualified Bidders/Suppliers.
3. Interested Eligible Bidders may obtain further information and inspect the bidding document in English at the Office of Rural Municipal Executive, Khopawa, Bara.
4. A complete set of Bidding document may be purchased from Baragadhi Rural Municipality, Office of Rural Municipal Executive, Khopawa by eligible Bidders on the submission of a written application along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Nrs. 3000.00/- during office hours till 2078/01/06.
5. Pre-bid meeting shall be held at Baragadhi Rural Municipality, Office of Rural Municipal Executive, Khopawa, Bara at **1.00 P.M. on 2077/12/24**.
6. Interested Bidders must submit the Sealed Bids to the Office of Baragadhi Rural Municipal Executive, Khopawa by hand/courier on or before **12:00 P.M. till 2078/01/07**. Submission of Bids after this deadline will be rejected.
7. Submitted Sealed Bids shall be opened in presence of Bidders' representatives who choose to attend at **2:00 P.M. on 2078/01/07** at Baragadhi Rural Municipality, office of Rural Municipal Executive, Khopawa, Bara. But nothing shall bar the opening of Tender by the reason only that any bidder or its agent is not present. Bidder's representative should bear the authorization letter duly signed by the authority of firm at the time of bid opening.
8. Sealed Bids must be valid for a period of 90 days counting from the date of bid opening and must be accompanied by the bid security (Bank Guarantee or Cash Deposited into Bank) amounting to minimum of NRs. as per table given below.:
